The Bidders must submit their bid electronically through e-procurement section of PPMOs website <http://www.bolpatra.gov.np>, the Bidders may choose to download the necessary part of bidding documents, prepare their bid and submit their electronic bids as specified in the instructions to Bidders. Bidder should download and submit bid electronically, the Bidder shall be required to deposit the non-refundable fee of NRS. 3,000 in the account as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher shall also be submitted along with the electronic bid files.
3. Electronic Bid must be uploaded in PDF on or before 12.00 hours on 30th day from the date of publication. Bids received after the deadline shall not be accepted.
4. Bids shall be opened in the presence of Bidders' representatives, who choose to attend with original related documents at 2:00 PM on 30<sup>th</sup> day of Notice Published. Bids must be valid for a period of **90 days** counting from the day of bid opening.
5. Bid shall be accompanied by a bid security of an amount as shown in the above table. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the following address or a bid bond issued by a bank approved by Nepal Rastra Bank valid beyond a month from bid validity period and submit the original receipt of the deposited amount of cash along with the bid.

Except the mentioned clauses all other conditions of the bidding process must be followed the Public Procurement Act, 2063 and Public Procurement Regulations, 2064.
8. In the case of discrepancies or error in bid documents, bid notice or any other documents, Chure Rural Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.
9. If bidders are not manufacturer, they must submit sole authorization letter from the manufacturer or from the authorized distributor of the manufacturer.
10. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
11. Chure Rural Municipality office reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
