The E-bids will be opened in the presence of E-bidders' representatives who choose to attend on 14:00 PM of 21st September, 2025 at *Office Of the Rural Municipal Executive (CRM), Gharkheda, Kailali*. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amount as mentioned in above table, which shall be valid for 30 days beyond the validity period of the bid.
7. If E-bidder wishes to submit the E-bid Security in the form of cash, the cash should be deposited in *Dharauti Khata* No. 0820529963703003 at *Laxmi Sunrise Bank Ltd. Sahajpur, Kailali Branch* and submit the receipt of the deposited amount of cash along with the E-bid.
